- 1. Annual Pass is non-refundable, may only be used by the registered users, and may not be reassigned to another person.
2. Pass is valid for the 2019 golfing season, beginning March 1 and terminates February 28, 2020. A one-time proration will be honored for any new pass purchaser. Golf course/range can close at any time without notice.
3. Family Passes consist of adults and their dependent children ages 22 and under. Children 17 and under may not drive carts on golf course property.
4. Tee-time reservations may be made 16 days in advance by Platinum pass holders and 14 days in advance for all other pass holders.
Annual Pass holders MUST check in prior to tee time or playing.
5. Pass holders may make one advance tee time per day. Additional same day rounds may be played on a space available basis.
6. Pass holders will be charged the Owner greens fees rate for tee-times not cancelled 24-hours in advance.
7. Pass holders receive two complimentary buckets of range balls per day. Range balls and baskets are not to be removed from the golf facilities. Range privileges valid March 1 – November 31.
8. Pass holders will acknowledge receipt of golf cart(s) in good working order and keep the cart(s) in the same condition. If a golf cart is not in good condition, Pass holder agrees to return/refuse it and inform the golf-shop immediately. Pass holder agrees to operate the golf cart(s) in a safe manner and comply with all signs, rules, requirements and directives from RunningY and/or its personnel. Carts shall stay on maintained turf area's only and be kept a minimum of 20 yards from the edges of tees and greens. Carts are to stay on paths when directed. Pass holder agrees to reimburse RunningY for any and all damages (other than ordinary wear and tear) that occur during the time pass holder is in possession of/responsible for the cart(s). Pass holder agrees to defend, indemnify and hold harmless RunningY, its officers, agents, parent, and employees from any and all injury claims, including death and/or damage to any person/property arising from or related to the use/rental of golf cart(s). Pass holder accepts full responsibility for the cart(s) and their actions while on the golf course.
9. Pass holder guests will receive discounted golf rates. Guests must play with pass holder to receive discount.
10. Pass holder may obtain handicap flags in the golf shop with proof of medical condition.
11. RunningY reserves the right to cancel or modify the Annual passes at any time without notice.
12. RunningY reserves the right to revoke the privileges of a pass holder, without refund, who violates any agreed condition above.
13. Full Payment is due on or before September 30.
14. Credit Card on file required for payment plan.
15. A late payment fee of \$50 per week will be charged to any plans not paid in full by 9/30. If late fees are incurred, payment plans may be refused in future years.
